Second is a friendly reminder that the requirements for each syllabus are noted at the front of these documents as follows:


Three pieces by three different composers are to be presented. A minimum of two pieces are to be from the NZMEB syllabus list. The third piece may be an own choice piece and should be at a similar level to those already in the syllabus. The syllabus repertoire lists below may be used as a source for an own choice piece. Entrants must bring a copy of the own choice piece to the examination for the examiner to refer to.

We have added some of the Suzuki repertoire to our syllabuses. It is not yet online, but will be by the beginning of the term. If you have any queries about it earlier please contact me.
